New Business:

- Barton Water Counter Offer Eli Stockstill gave a brief history of contract negotiations. Communication between the water systems need to be made a priority. Discussion of scheduling a yearly meeting to discuss what the next year is looking like for each water system in May Meeting. Agreement was met on the acceptance of New Rate then when the new rate was to be paid. Old Rate of \$4.38 will be paid on June & July bills, and then new rate of \$6.21 will be on Aug bill and continued on the duration of the contract. Roger made Motion to Accept Barton Water Proposal to Counter Offer to pay the old rate of \$4.38 through June 30, 2017 and new rate of \$6.21 as of July 1st, 2017, 2nd by Albert. All Voted For. Motioned Carried.
- Barton Water Exempted out of CCN- Hwy 919 Barton Water does not want to supply water to Twin Mountain. But there is 8 Meters on Mitchell Hill, which is Valved off at the Gun factory which is on Elkins land. Motion to Accept the Exemption from Barton Water by Albert. 2nd by Roger. All Voted For. Motion Carried.

Old Business:

• Water Taps Water Lines Extensions & Sewer Tap Rates Inside & Outside City Limits: Water Taps Inside City Limits - \$250

Water Taps Outside City - \$2000

Sewer Taps Inside & Outside City Limits – Barry Tiptop was supposed to be at the Meeting, but did not show up. Barry is supposed to work with Derek with Jacob & Martin to engineer a plan for Twin Mountain to Plan Sewer into City Waste Treatment Plant. – Tabled until Engineering Solution that is feasible to the existing Waste System.

- Steve Larison Sewer Leak January 2017 Steve Larison was not present at the meeting, but there is no liability on the City's part due to Governmental Immunity & Liability of Municipality. Sending a letter that informed from Consult from Attorney
- Plumbing Invoices of Water Leak Repairs Pat Jewell & Pam Martin the plumbing issues were thought to be the City's fault from the water department. There was a leak due to the State mowing the ditch and breaking a valve. We fixed the leak, then something was in the line that the Invoices say were the problem for their water problems. Letters were sent to them as well.

- Moving 40 MPH Speed Limit Sign to City Limits Teresa has to call to get Traffic Study
